As a part of this, a number of globally-acclaimed faculty members of the ISB addressed them on such themes as Mindful Leadership, Digital Transformation in Public Governance, Data Needs for Development, Urbanization & Smart Cities, Capacity Building Initiatives of the ISB in Government, Monitoring & Evaluation of Government Schemes, etc.

Dr. Sripada Chandrasekhar, Professor & Executive Director, Centre for Human Capital & Leadership Initiatives said that the mind-boggling changes that have taken place in the profile of employees in Government sector call for corresponding changes in the leadership styles of civil servants. He called upon them to adopt servant leadership in order to fulfil the dynamic aspirations of different stakeholders.

Dr. Chandra Chowdhury, Executive Director-MIGM & Professor of Operations Management & Information Systems said that citizens are the most important stakeholders in the conceptualisation and execution of projects for smart cities. He presented case studies of Singapore, Chandigarh, and Amaravati to highlight the challenges relating to urbanization and smart cities.

Professor Ashwin Chhatre, Visiting Professor in Economics & Public Policy advised the OTs to use data as extensively as possible in order to improve quality of their decisions.

Panel Discussion on SDGs

The Institute conducted a "Panel Discussion on Sustainable Development Goals (SDGs)" on November 2nd, 2017. Sri Yuri Afanasiev, United Nations Resident Coordinator in India paid glowing tributes to India for playing a leadership role in defining contours of major global agreements relating to SDGs. "It is commendable to see that Government of India is showing strong commitment to SDGs by launching innovative schemes in order to achieve their goals", he said.

Dr. A.K. Jain, Advisor, NITI Aayog said that SDGs are equally relevant to all civil servants, irrespective of the services to which they belong. He stated that SDGs are inter-connected and, therefore, need extensive inter-departmental coordination among officers rather than confining themselves to their watertight compartments.

Sri B. P. Acharya, IAS, Special CS Planning & DG of the Institute, who moderated proceedings of the Panel Discussion, underlined the importance of SDGs for the multifaceted and inclusive development of the country, and added that the e-Learning modules produced by the Institute, will go a long way in creating awareness about SDGs among a whopping 9000 Government employees at grass roots level.

Army Symposium

The Institute conducted an Army Symposium on November 15th, 2017 in order to sensitize the OTs issues relating to national security. Major Officer N Srinivas Rao, General General Commanding, Telangana and Andhra Sub Area addressed the OTs on "Shaping Our Immediate Neighbourhood: India's Biggest Security Challenge". Major General Rao gave away Gold, Silver, and Bronze Medals to Sri Mohit Handa, IPS, Sri Ganesh Kumar, IPoS, and Sri Wavhal Vaibhav Balasaheb, respectively in the Army Essay IRS (C & CE), Competition 2017, conducted by the Army HQ for the OTs.

Sri B P Acharya, IAS, Spl. CS Planning and DG of the Institute said that both civil servants and army officers have an important role to play in taking the country to greater heights and stressed upon the need for a live interface and cooperation between them in achieving the national goals. While paying glowing tributes to the Indian army for its worthemulating role in the relief and rehabilitation work, as and when calamities struck the country, he called upon civil servants to support army personnel not only during their service but also after their retirement.

Dr. P Srinivas Memorial Lecture

The Institute organized Dr. P Srinivas Memorial Lecture on "Challenges in Left Wing Extremism Affected Areas", on September 12th, 2017. The lecture was delivered by Sri K Vijay Kumar, IPS (Retd.),

Senior Security Advisor, Ministry of Home Affairs, Govt. of India. "Mere killing of terrorists is not the full answer. Addressing the issue is equally important", he said.

Sri Vijay Kumar pointed out that a 'service is a product' and police is a service and the public are entitled to a fine product - namely, a top class policing. He stated that for police reforms, integrated interventions, rather than piecemeal initiatives, are needed.

Sri Vijay Kumar said that mere establishment of police stations is not enough in controlling crime. He cited the backlog of cases on trial. "Once a crime occurs, the detection - arrest - recovery - prosecution-penalty/imprisonment are a continuum between each of which there should be the least gap", he said and called for better coordination among State and Central Governments, police, army, and different departments of Government for finding an enduring solution to the problems of insurgency.

Advising the OTs to become impact-making leaders, Sri Vijay Kumar said that if they are equipped with right moral compass and up-to-date professional skills, political interference is more imaginary than real.

Award of e-Learning Program Completion Certificates

The Institute awarded certificates on November 16th, 2017 to 125 OTs, who successfully completed 15 e-Learning modules, designed by DoPT, Government of India. Sri K. Srinivas, IAS, Joint Secretary, DoPT, who was the Guest of Honour at the event, called upon the OTs to learn and perfect the art of administration, on a continuous basis, in order to keep their skill sets current and up-to-date. He stated that civil servants are required to respond to the expectations and aspirations of people, at a fast pace, considering the spectecular changes that have been taking place at the place of work and the society at large.

Five batches of "Orientation Program on AMRUT Mission" were conducted for the officers of Madhya Pradesh State during the months of September and October 2017. Over 120 officers attended the program. The program had two main concentrations - one was familiarizing the participants with urban development strategies within the ambit of the AMRUT Mission and second was introducing the best practices in mission priority areas.

"A three-day Orientation Program on AMRUT" was conducted during first week of August 2017, which was attended by 23 participants representing the GHMC from various zones. The focus of the program was on the issues relating to effective implementation of AMRUT Mission.

Six batches of five-day "Induction Training Program Health Officers and Municipal **Engineers of GHMC"** were rolled out during the months of September, October, and November 2017. About 275 participants attended these programs. The program focused on methods used to design, operate, and maintain the systems, specifically related to water supply, sanitary sewer, and storm drainage.

A training program on "Communication and Presentation Skills", was conducted from August 8th to 10th, 2017. The program, which was attended by about 45 participants, covered the following topics: process of communication, verbal-& non-verbal communication, and strategies to improve quality of communication, etc.

Telangana Orientation - 2

Innovations in Governance: Exemplars from Telangana Districts

"Localized innovative interventions in governance became a key to break the historical development challenges that our country is facing. It is encouraging to note that a range of localized innovations, from little tinkering of guidelines to wholesome new interventions, are being undertaken by district administration, especially in the toddler districts of Telangana."

'Whatever you can rightly say about India, the opposite is also true' argues Amartya Sen. True to his thought, development initiatives in a country like India, distincts with heterogeneous cultures, diverse socio-economic conditions, vast geographical area and immense rural-urban differences require localized solutions to address their long-pending developmental challenges. This could happen with innovative governance practices at district level.

While wholesome change in guidelines may not be desirable, the district administration is required to adapt innovative governance practices to suit the local conditions for better implementation of the schemes. It is heartening to note that many districts in Telangana have come up with a range of innovative interventions from little tinkering of existing rules to wholesome change in the scheme eco-system for its effective implementation. These initiatives cut across various sectors including livelihoods, health, education, child welfare, sanitation, and social security. A glance at a few such innovative practices is presented below.

Nalgonda district administration started 'Maa Inti Laxmi' campaign to eradicate discrimination against girl child. Declining child sex-ratio (proportion of female children to male children) is a major cause of concern in tribal areas of Nalgonda. The district administration adopted a comprehensive strategy of sensitization, formation of village - level child protection committees, effective implementation of PNDT Act, etc. under this initiative. Except waiting for the numbers, the campaign has a huge positive impact in mobilizing public opinion towards 'save girl child campaign'.

A number of districts undertook reforms to overhaul functioning of Government - run hospitals. Sangareddy district administration developed 'Expected Date of Delivery Calendar' and 'e-Health Module' to track and facilitate institutional

delivery of pregnant women in Government hospitals and provide accurate immunization schedule to the new born. Medak district initiatives administration took to promote institutional and natural delivery in public hospitals. Survapet district administration is working towards revamping of all PHCs to improve services delivery, at par with the corporate hospitals.

Mahabubabad district initiated measures to modernize the ICDS centres by providing state-of-art facilities. As a result, there is a sharp rise in attendance and enrollment of children in these centres.

Open defecation has adverse consequences on human health, dignity, and environment. Quite a number of districts are declared as Open Defecation Free (ODF) districts in Telangana. Many districts are working on mission-mode to build individual toilets to make the Telangana an ODF State.

A few districts have launched district - specific innovative livelihood initiatives. The 'e-Banker Module' in Sangareddy simplifies procedures for availing of farm loans. Banks can now get all the land-related documents online from the revenue administration, thus, relieving farmers from unnecessary documents-related duress. e-Mancherial app, initiated by Mancherial district administration, provides information on urban lands such as land ownership, use, taxation, value, etc. Asifabad and Adilabad districts are making concerted efforts to improve earnings of tribals.

Though this is not an exhaustive list of localized innovations in the State, the takeaway is that there are no "one-size-fits-all" solutions and new ideas make a difference. Emerging competition among the districts in Telangana State to think out-of-the-box and implement new processes and methods is bringing in its wake a number of benificial outcomes.
