Telangana Orientation - 3

Growth from Bottom: Rejuvenating Agriculture and Allied Sectors in Telangana

Such interventions as increased irrigation, better investment support, dissemination of improved technologies, effective extension reach, efficient input delivery, increased availability of credit, extensive crop insurance, etc. will give a big boost to the rural economy, increase the income of people at the bottom rung of society, and lay a strong foundation for realizing the dream of Bangaru Telangana.

The State economy has moved decisively to a higher growth phase in a short span of time. The growth rate picked up from a low annual average growth of 4.2% in pre-formation era to an elevated annual average growth of 9% in post-formation. The upward shift in growth frontiers of the State economy is due to the improved performance of the services sector. However, agriculture and allied activities have been the sources of livelihood for about 55% of the total workforce in the State.

Higher growth in agriculture assumes great importance to achieve sustained economic growth and overall wellbeing of the State's population. Recognizing this, the Government has focused on such interventions as increased irrigation, better investment support, dissemination of improved technologies, effective extension reach, efficient input delivery, increased availability of credit, extensive crop insurance, etc.

In an effort to build drought proofed agriculture, the State has undertaken construction of major and medium irrigation projects. Minor irrigation tanks are being renovated through Mission Kakatiya. Irrigation through revival of age-old tanks and construction of new projects will rejuvenate rural Telangana through its multiplier effect. Several initiatives in agriculture sector, such as launch of flagship programs, farm mechanization, continuous power supply to all agricultural pump-sets, incentives to micro-irrigation practices, awareness programs for farmers on modern cultivation methods, availability of inputs such as seeds, fertiliser, etc. at the doorstep of farmers have made their mark in creating a supporting network for farmers. The Telangana State is all set to launch the Rythu Bandhu scheme to provide investment assistance of Rs. 8000 per acre to farmers.

Extension services are made available to each agricultural cluster of 5,000 acres consisting of about 2 - 3 revenue villages. Rythu Vedikas are being constructed in every cluster to facilitate interactions

among farmers. Regular training programs are being organised to train farmers on modern scientific techniques of cultivation. Farmers' Coordination Committees (rythu samanvaya samithis) are formed at village, mandal, district, and State levels to ensure that Government schemes reach the needy farmers. The samithis will play an active role in transforming agriculture into a profitable business by undertaking activities like procurement, storage, processing, and marketing of agriculture and horticultural crops and their products.

It is estimated that about 40% of the farmers' income accrued through allied activities such as animal husbandry, fisheries, agro-processing businesses, etc. Allied activities widen the income base of rural communities and provide income throughout the year. There has been an increase in demand for allied products such as milk and meat with enhanced average income.

Keeping the above in view, the State Government has adopted a comprehensive approach to develop non-farm activities through initiatives such as development of dairy sector, distribution of sheep, fish seedlings, fodder supply, etc. The State launched a massive sheep distribution program consisting of 20+1 sheep unit to 4 lakh members of the Primary Sheep Breeders Cooperative Societies. In view of the presence of traditional occupational communities, various sector-specific measures have been initiated for their welfare.

Some of these initiatives are first of their kind in the entire country and have got acclaims from various Governments for their innovative conceptualization and efficient implementation. The initial impact of these initiatives has been encouraging. Tapping of their full potential will give a big boost to the rural economy, increase the income of people at the bottom rung of society, and lay a strong foundation for realizing the dream of Bangaru Telangana.
