## ORDER:

In Government Order first read above, orders have been issued constituting a Committee for examining various aspects of delegation of Financial and Administrative powers to the Heads of the Institute of Administration, Andhra Pradesh Police Academy and other Training Institutes.

In G.O. 2<sup>nd</sup> read above, Government have agreed to the recommendation of Committee subject to certain modifications. Accordingly financial and administrative powers were delegated to the Heads of Category - I and Category-II training institutes in the State as detailed in Annexure-I, II, III, IV, V and VI to the order. Dr.MCR HRD Institute of A.P and A.P.Police Academy both fall in Category-I training institutes.

The Director, APPA, Hyderabad in his letter 3<sup>rd</sup> read above  $\nu_{\rm has}$  stated that , since 1989 to till date the rates of examination charges have not been revised. Due to low rates of Examination Charges, most of examiners (both internal and external) are not showing any interest to work in the examinations. They have stated that it is very difficult to conduct the examinations due to lower rates The A.P.P.S.C, Universities like Osmania, of remuneration. Hyderabad Central, Potti Sreeramulu Telugu University have revised their examination charges several times since 1989. fixed for the examination charges APPA Vide G.O.Ms.No.561, G.A (AR&T.III) Dept., Dt:7.10.1989, have not been revised so far. There is a need to revise the examination charges on priority basis in order to conduct the Slip tests, Pre-final and Final examinations etc (both indoor and out door) in the Academy in a free, transparent manner by utilizing the services experts/professionals. The Director, APPA has furnished the revised

proposals for enhancement of examination charges i.e paper setting from Rs.250/- to Rs.1000/-, Valuation of Answer Scripts from Rs.5/- to

Rs.10/- and Invigilation charges from Rs.100/- to Rs.300/-.

- 4. Government have carefully examined the above proposal and reviewed the revision of existing examination charges in Andhra Pradesh Police Academy and Dr. Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh and have decided to revise the rates of examination charges.
- 5. Accordingly, Government hereby direct that the orders issued in G.O.2<sup>nd</sup> read above, to the extent of examination charges shall be revised from Rs.5/-to Rs.20/- for paper evaluation and Rs.250/- uniformly for paper setting. Accordingly, the entry at item No.7 in Annexure-V of the G.O 2<sup>nd</sup> read above, will stand revised, in respect of only Dr.Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh and Andhra Pradesh Police Academy.
