#### **Course Guide :**

#### **Context:**

#### 1. Context:

Scheduled Tribe Community Certificate entails a person or provide a constitutional status to a person and his progeny to avail various constitutional safe- guards and reservations meant for Scheduled Tribes such as admission into educational institutions, scholarships and concessions, appointments, promotions, benefits under various developmental activities, eligibility for contesting elections under Scheduled Tribe reservation from ward Members of Gram Panchayat to Member of LokSabha. The Scheduled Tribe certificate holder is also provided protection from exploitation and relief in the event of atrocities committed on them.

The Revenue Officials, who are the competent authorities for issuance of community certificate, generally in view of their multifarious activities, may feel this function of issuing community certificates is of less importance and may not devote much attention and act in a routine manner. In view of the above mentioned constitutional benefits that will accrue to the Scheduled Tribe certificate holders and their progeny and the magnitude of loss of benefits to rightful claimants the authorities shall devote much attention and importance to this subject.

Some of the non-tribal groups having similar name of caste groups and some non Tribalcommunities having affinity to Tribal groups like Thoti, Nakkala, LingadhariKoya, Kammara, Goudu etc., are fraudulently obtaining ST certificates taking advantage of the similarity in the names of their community with those of Scheduled Tribes.

Some of the migrants are also fraudulently obtaining ST certificates and enjoying benefits meant for STs. For instance persons belonging to Banjara Community in Maharashtra State which is notified under BC community are married Lambadi persons in Telangana which is notified as ST in Telangana State and claiming their status as ST.

In cases of inter caste marriages, no person who was not Scheduled Tribe by birth will be deemed to be member of Scheduled Tribe merely because he or she had married a person belonging to a Scheduled Tribe. Similarly, a person who is a member of Scheduled Tribe would continue to be a member of that Scheduled Tribe as the case may be even after his/ her marriage with a person who does not belong to a Scheduled Tribe.

In the cases of children of Inter Caste Couple the candidates are obtaining the ST Status certificates though they are not brought up in the midst of tribal culture and customs.

Due to lack of knowledge on various above mentioned issues, Thasildars are issuing ST community certificates, though the competent authority for issuance of community certificates are RDOs/sub-collectors with respect to certain communities which do not have traditional habitat in their area of jurisdiction. There are clear rules and guidelines as like in plain area, only Revenue Divisional Officer is competent to issue KondaKapu Certificate.
