Objectives :

- ▶ To ensure monetary, medical relief, including reconstructive surgeries, to women/girl child who are victims of heinous crimes, as well as educational assistance to the victims and their minor children.
- ▶ To provide medical and educational assistance for women/girl child who may not be directly victims of heinous crimes but require critical social and economic empowerment.

Eligibility–

- ▶ All women pensioners who have been covered under Any Social Pension Schemes by Govt. of India or the State Govt.
- ▶ Minor girl child /children of all women pensioners.
- ▶ Destitute women residing in Govt.homes.
- ▶ Girl child inmates residing in Govt./NGO run Children Homes, Special Homes, Protection Homes, etc established/registered under Juvenile Justice Act 2000.
- ▶ Any other category of beneficiaries, if found below poverty line , as recommended by the District Steering Committee under District Magistrate and approved by the State Monitoring Committee headed by Chief Secretary.

Contribution to the Kosh–

- ▶ State Govt. has contributed Rs. 100 crores to operate the Kosh, which can be increased, as and when required in a financial year
- ▶ Public contributions can be made online through Net Banking/Credit Card/ Debit Card in Account No. 34681306554 of the Kosh with State Bank of India, Jawahar Bhawan Branch, Lucknow or through Demand Draft/Cheque in favour of "Uttar Pradesh Rani Laxmi Bai Mahila Samman Kosh" payable at Lucknow. Online payment is linked with E- receipt portal of Finance Dept.
- ▶ Donations made by the individual/institutions to the UP Rani Laxmi Bai Mahila Samman Kosh is exempted from the payment of the Income Tax under the section 80G of the Income Tax Act, 1961.

1. Kosh is administered through a transparent, online interactive public portal.
2. Under the KOSH rules, victims of heinous crimes need not submit any application. The FIR and medical Report is uploaded online by district nodal officers .
3. The District Steering Committee headed by the District Magistrate, submits recommendations online in the website www.mahilakalyan.up.nic.in/MSK
4. Competent authority of KOSH ensures online Fund Transfer to the account of beneficiaries through Public Financial Management System under the E-payment system of the treasury and SMS alert at various levels.

5. Integration of various Stake Holders (Police, Medical, Legal, Probation, Treasury, District Administration & Public).
6. Instant availability of Information and Application Status online through internet on 24X7 basis.
7. Secured & Authentic Data Management.
8. Transparency in maintenance & flow of funds.
9. Contributions and Expenditure under the Kosh are available online.

Provision for medical treatment

1. Cashless treatment for eligible beneficiaries
2. Referral medical colleges of the State such as King George Medical University Lucknow, SGPGI Lucknow, and medical colleges of Allahabad, Meerut and Jhansi have been given imprest money from the Kosh for treatment of eligible beneficiaries.
3. The KOSH funded Rs. 7.41 Crore to King George Medical University Lucknow to establish a modern Burn and reconstructive surgeries Unit with 25 beds in the Department of Plastic Surgery.

ONLINE MAHILA SAMMAN KOSH PROCEDURE

- ▶ Feeding and Uploading of Victim details by Nodal Police Officer in District.



- ▶ Uploading and Forwarding Medical Examination Report of Victim by Nodal Medical Officer in District.



- ▶ Approval and Forwarding All Reports to Prescribed Authority by District Steering Committee.



- ▶ Prescribed Authority after receiving recommendations from DSC with all uploading reports gets amount sanction from Principal secretary.



- ▶ After the Approval of PS beneficiary files upload on PFMS.



- ▶ PFMS returns those beneficiary files after verification from the banks.



- ▶ Then Treasury bill prepared and produce for treasury token.



- ▶ With treasury token transaction file prepared and upload on PFFS .



- ▶ PFMS Compare beneficiary and transaction file details if both match then approved transaction by PFMS.





- ▶ DDO of Scheme and Treasury officer both approve the transaction file online by using their ID and Password.




- ▶ After approval of TO sanctioned Amt. Transferred in the beneficiary bank account.



- ▶ Report of every stage can be generate online by any stakeholder.


PFMS – WORK FLOW FOR FUND TRANSFER

Capacity Building of Medical Officers for Enhanced Forensic Medico-legal Examination Skills.

- ▶ Special focus laid on enhancement of scientific forensic examination skills of Medical Officers for conducting effective Medico-legal Examination .
- ▶ The department has been able to create a panel of more than 500 Medical Officers as Master Trainers on this subject. The objective is to enhance the skills of all the Government medical officials.

Kosh has helped these beneficiaries

1. Kosh funded SGPGI Lucknow for operation of Carniopagus and Ano Rectal Malformations in twin girl children of Rajesh Soni, of Unnao district to the tune of Rs.5 lakh., thus helping save their lives.
2. Jyoti Rathore , Lucknow and topper of UP Secondary Education Board Exam of 2014-15 is studying in BITS Pilani, Rajasthan.. Her father was not able to pay the fees An amount of Rs. 1.44 lakhs paid from the KOSH towards second semester fee and would be continued for the entire Course.

3. Samprada Tripathi, resident of Kanpur Dehat requires regular oxygen intake due to serious medical ailment. Due to dire poverty her family could not afford the expenses of treatment, which is now being extended under the Kosh
4. Saira Bano, resident of Noida, got electrocuted thereby damaging both the eyes and nose. From the KOSH, an amount of Rs. 4,51 lakhs has been given for her reconstructive surgery, as she belongs to a poor family.

5. A sum of Rs. 5 lakhs has been sanctioned to SGPGI, for treatment of thalassemia patient Ayush from Siddharthnagar.
6. A sum of Rs.7.50 crore has been provide to KGMU for establishment of modern burn and reconstructive unit for the better treatment of acid attack victims.
