






'Staircase' Model of Corruption




Corruption at High Places

Facts on Corruption in India

- Corruption is part of Indian Democracy..
- Expenditure Assembly Rs. 2.5 5 Crs (EC Cap Rs. 40 Lakhs); Lok Sabha – Rs. 5 - 20 Crs(EC cap Rs. 95 Lakhs)
 Black Eco : App. 14% of India's GDP (Rs. 23, 849 Bn (2017))
 Wealth of India's richest: India's richest 1 % hold more than four-times the wealth held by 953 million people who make up for the bottom 70% of country's population.
- India has the highest overall bribery rate (39%) and the highest rate of citizens using personal connections (46%). (Source: Global Corruption Barometer Asia by Transparency International 2020)

Some facts on Corruption

- More than 50% of Indians bribed government officials in 2019, finds the latest India <u>Corruption</u> Survey conducted by LocalCircles and Transparency International India.
- A massive leak from one of the world's biggest private banks, <u>Credit</u> <u>Suisse</u>, has exposed the hidden wealth of clients involved in torture, drug trafficking, money laundering, corruption and other serious crimes. Details of accounts linked to 30,000 Credit Suisse clients all over the world are contained in the leak, which unmasks the beneficiaries of more than 100bn Swiss francs (£80bn) held in one of Switzerland's best-known financial institutions.
- On April 28, 2021, the UK's Serious Fraud Office (SFO) <u>announced</u> that GPT Special Project Management Ltd. (GPT), a former subsidiary of Airbus SE which ceased operations in April 2020, had pleaded guilty to one count of corruption/ violation of Section 1 of the Prevention of Corruption Act 1906. The company was ordered to pay a confiscation order of £20.6 million, a fine of £7.5 million, and the SFO's costs of £2.2 million.



NATIONAL HUMAN RIGHTS COMMISSION Prevention of Corruption Act, 1988

The offences under the P.C. Act 1988 can be broadly divided in THREE groups:-

- **TRAP** (Secs. 7, 8, 9, 10, 11, 12, 13(1)(a) and (b) and Sec.14),
- <u>ABUSE OF OFFICIAL POSITION & CRIMINAL</u>
 <u>MISAPPROPRIATION</u> (Sec. 13(1)(c), (d) and Sec.
 15)
- **DISPROPORTIONATE ASSETS** (Sec. 13(1)(e).




Amendment of Section 12

 Whoever abets any offence punishable under this Act.....

 Implication on DA Cases: Now abettor of DA Cases are to be prosecuted U/s 12 of PC Act 1988 and not U/s 109 of IPC








In layman's language, Trap means, catching someone unaware while doing objectionable act. But from anti-corruption point of view, Trap means catching a public servant, as defined in Section 2(c) of the PC Act, 1988, accepting bribe for showing favour or for the favour already shown or forbearing to do so.






